**Hong Kong Ski Team Selection**

**A. Hong Kong Ski Team Selection - Future Star Member**

1. Eligibility

- 1.1 Must be a Hong Kong resident or holder of a HKID card.
- 1.2 Age 8 to 11.

2. Selection Method to join HK Ski Team (Future Star Member)

- 2.1 Performance at one of our Future Star Assessments OR
- 2.2 Recommended by authorized Ski Club Professionals/Coaches OR
- 2.3 Selection Criteria include tournament results, evaluation of technique, athletic ability, communication skills, personal behavior etc. OR
- 2.4 Tournament results from Hong Kong Inter-School Championships.

**B. Hong Kong Ski Team Selection – Bronze Badge Member**

1. Eligibility

- 1.1 Must be a Hong Kong resident or holder of a HKID card.
- 1.2 Age 12 and above
- 1.3 Promoted from Future Star Member when age 12.

2. Selection Method to join HK Ski Team (Bronze Badge Member)

- 2.1 Performance at one of our General Assessments OR
- 2.2 Recommended by authorized Ski Club Professionals/Coaches OR
- 2.3 Selection Criteria include tournament results, evaluation of technique, athletic ability, communication skills, personal behavior etc. OR
- 2.4 Tournament results from Hong Kong Inter-School Championships.
- 2.5 Responsibility of Bronze Badge Member
  - (a) Must attend at least one (1) Oversea Tournaments.
  - (b) Must attend at least two (1) overseas training organized either by SA-HK or recognized ski clubs.

**C. Hong Kong Ski Team Selection – Silver Badge Member**

1. Eligibility

- 1.1 Must be a Hong Kong resident or holder of a HKID card.

#### 2. Selection Method to join HK Ski Team (Silver Badge Member)

2.1 Performance at one of our General Assessments OR

2.2 Recommended by authorized Ski Club Professionals/Coaches OR

2.3 Selection Criteria include tournament results, evaluation of technique, athletic ability, communication skills, personal behavior etc. OR

2.4 Tournament results from Hong Kong Inter-School Championships.

2.5 Responsibility of Silver Badge Member

(a) Must attend at least two (2) Oversea Tournaments.

(b) Must attend at least two (2) overseas training organized either by SA-HK or recognized ski clubs.

#### **D. Hong Kong Ski Team Selection – Gold Badge Member**

##### 1. Eligibility

1.1 Must be a Hong Kong resident or holder of a HKID card.

1.2 Age 12 and above.

1.3 Promoted from Silver Badge Member.

##### 2. Selection Method to join HK Ski Team (Gold Badge Member)

2.1 Recommended by authorized Ski Club Professionals/Coaches OR

2.2 Selection Criteria include tournament results, evaluation of technique, athletic ability, communication skills, personal behavior etc. OR

2.4 Tournament results from Oversea Tournaments

2.5 Responsibility of Gold Badge Member

(a) Must attend at least Four (4) Oversea Tournaments.

(b) Must attend at least Three (3) overseas training organized either by SA-HK or recognized ski clubs.

**Note: SA-HK reserves the right to amend the above rules.**

#### **Tournament Selection Process**

1. SA-HK will circulate approved tournament lists to relevant members of the Hong Kong Ski Team;

2. The team list of each tournament will be developed and approved by the Selection Committee;

3. SA-HK will inform team members of the number of spots available, tournament information, departure and return dates and specific selection criteria for this tournament, and request them to reply in writing regarding their availability by a specified date;

4. The Selection Committee will select from the available team members based on the specific criteria for each tournament;

5. SA-HK will inform the selected skiers and announce the selection results to the rest of the team.

6. Tournament Selection Criteria: (a) Entry requirements set by the tournament organizer; (b) FIS Ranking if any, (c) Tournament results and overall performance of the skier up to the selection date, (d) Participation and commitment to the team, (e) Discipline and attitude of the player, (f) Selection Committee may consider skier who have had recent outstanding results, (g) Selection Committee reserves the right to make the final decision as to whether or not to send players to overseas tournaments.

### Right of Appeal

1. A skier may appeal the decision of the Selection Committee to the Executive Committee by giving a written notice to SA-HK within 14 days of the date of decision by the Selection Committee being communicated to him/her.
2. Upon receiving the request, the Executive Committee must determine whether to:
  - 2.1 Dismiss the appeal; or
  - 2.2 Convene a hearing in relation to the appeal.
  - 2.3. In the event of a hearing, the Executive Committee will hear the appeal at such a time and in such a manner as the Executive Committee deems appropriate. A quorum of at least three members of the Executive Committee must be present to hear an appeal.

### Hearing

1. If the Executive Committee determines to convene a hearing in relation to the appeal, it must give at least 14 days written notice to the player stating: (a) The date, time and place at which it will hear and determine the appeal; (b) That the player is entitled to be assisted or represented by one other person or parent (if the player is Under 18 years of age).
2. If the skier is not present at the hearing, the Executive Committee may: (a) Proceed to hear and determine the appeal; or (b) Adjourn the hearing of the appeal for such period determined by the Executive Committee and must give written notice of the time and place when the hearing will resume.
3. If the skier is present, he/she may give evidence and bring any relevant witnesses to support his/her case.
4. After the presentation of evidence and hearing any final submissions by the skier the Executive Committee shall make such determination as it shall see fit in the circumstances.
5. The decision of the Executive Committee will, in its discretion, either be: (a) Announced at the conclusion of the appeal; or (b) Communicated in writing to the player within 30 days of the conclusion of the appeal.
6. The Executive Committee's decision is final.
