Skiing/Snowboarding Assumption of Risks and Medical Confirmation & SAHK Athlete Declaration

- Injuries resulting from my own physical and mental limits, including but not limited to fatigue, dizziness, headaches, which can affect the risk of accident.
- I certify that I am fully capable of participating in these activities.
- My participation in this event is purely voluntary, and I have chosen to participate in spite of and with full knowledge of the inevitable risks.
- I certify that I will purchase enough competition insurance, medical insurance and traveling insurance to cover any risk that I have taken during these activities which are associated with SAHK.
